APA reference lists only include works that can be found by the reader. As a personal interview is not published or "findable," it should not be included in an APA reference list. Instead, a personal interview should be referenced as a parenthetical citation. For example: (J. Smith, personal communication, May 17, 2008).

Place one double-spaced blank line between the paper title and the author names. Center author names on their own line. If there are two authors, use the word "and" between authors; if there are three or more authors, place a comma between author names and use the word "and" before the final author name.

Formatting an Interview for APA Style According to APA style guidelines, an interview is non-recoverable data, so you do not need to cite your interviewee in a reference list. Whether paraphrasing or quoting a source that you have interviewed, cite the interview in the main text after the quoted or paraphrased statement.

Citing an Interview in APA Format | Pen and the Pad

To cite a personal interview in APA, start by listing the initial of the interview subject's first name, followed by their last name, such as "R. Smith.". Next, insert a comma after the name and add "personal communication," followed by another comma.
